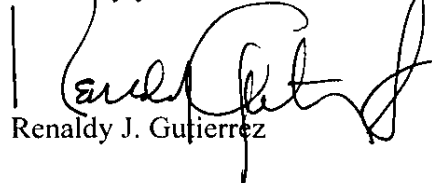

Pursuant to Section 608.445, Florida Statutes, we, the undersigned, hereby execute, acknowledge and file the following Articles of Dissolution for the purpose of recording the dissolution of 115 Partner, LLC, a Florida limited liability company, organized under the laws of the State of Florida, to wit:

**ARTICLE I - Name and Organization**

The name of the Limited Liability Company is 115 Partner, LLC (the "LLC"). The Articles of Organization were filed with the Florida Department of State on September 25, 2002 and assigned document number L02000025166.

**ARTICLE II-Meeting of the of the Members**

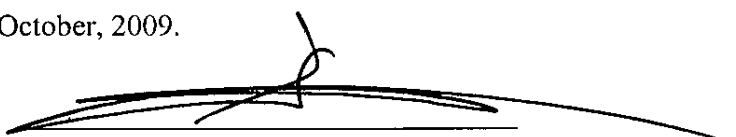
The members of the LLC by a unanimous written consent dated October 28, 2009 decided to authorize the dissolution of the LLC, pursuant to Section 608.441(c).
