ARTICLES OF ORGANIZATION

of

a Florida Limited Liability Company

ARTICLE I Name:

The name of this limited liability company is PRO-COUNSEL, LLC.

ARTICLE II Period of Duration:

The limited liability company's period of duration shall be perpetual, commencing on the date of filing of these Articles of Organization.
