**ARTICLES OF ORGANIZATION**

of

a Florida Limited Liability Company

**ARTICLE I Name:**

The name of this limited liability company is **PRO-COUNSEL, LLC**.

**ARTICLE II Period of Duration:**

The limited liability company's period of duration shall be perpetual, commencing on the date of filing of these Articles of Organization.

**ARTICLE III Registered Agent:**


ARTICLE VIII - Business Purpose and Powers:



IN WITNESS WHEREOF, the undersigned authorized representative has executed these Articles of Organization this 19<sup>th</sup> day of September, 2002.


