ARTICLES OF ORGANIZATION OF 1708 TEQUESTA, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes and files the following Articles of Organization.

ARTICLE I NAME

The name of the limited liability company is 1708 TEQUESTA, L.L.C. (the "Company

ARTICLE II DURATION

The period of the Company's duration shall commence on **September 20, 2002** and shall be perpetual, unless the Company is dissolved as provided for by law, by these Articles of Organization or in the Regulations ("Regulations") of the Company.
