**ARTICLES OF ORGANIZATION**  
**of**

**a Florida Limited Liability Company**

The undersigned hereby certify that they have associated themselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of limited liability companies for profit and hereby adopt the following Articles of Organization for such limited liability company.

**ARTICLE I - NAME AND PRINCIPAL OFFICE**

The limited liability company will dissolve as provided in the Operating Agreement executed by and among the members.

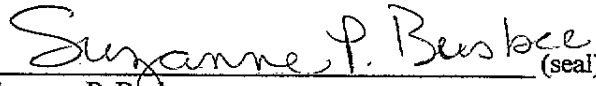

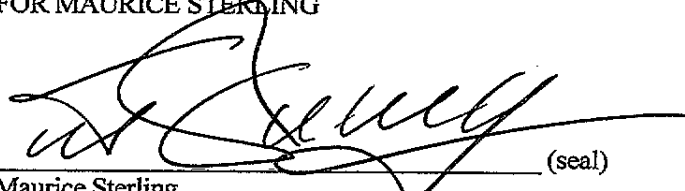
