**ARTICLE IV - Management**

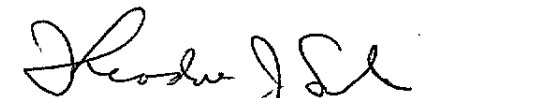
The Company will be managed by its members and is therefore a member-managed company.
