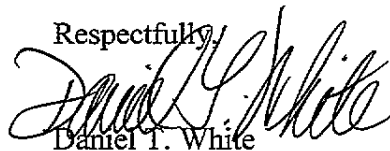

ARTICLE V: PURPOSE AND POWERS

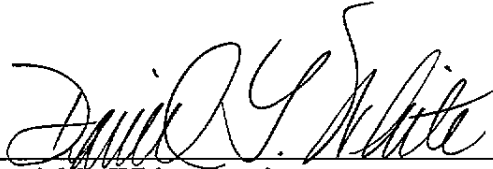

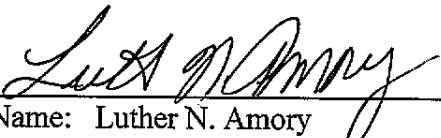
CERTIFICATE OF REGISTERED AGENT
