The members of the company shall contribute to the capital of the Company the cash, services or property set forth in the Company's Operating Agreement.

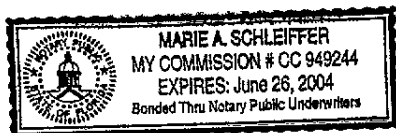
**ARTICLE VI – ADDITIONAL CAPITAL CONTRIBUTIONS**

## ARTICLE VII – ADMISSION OF NEW MEMBERS

## ARTICLE IX – MANAGEMENT

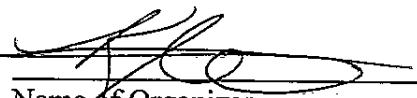

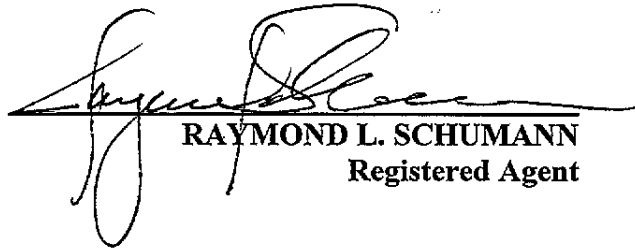
