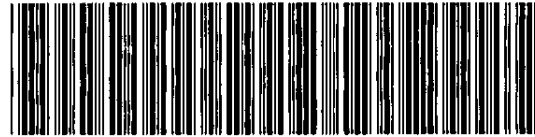


**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF**

**A FLORIDA LIMITED LIABILITY COMPANY**



2. Except as expressly stated herein, all other provisions of the original Articles of Organization of M & R Foods Management, L.L.C. shall remain in full force and effect.


