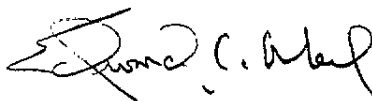

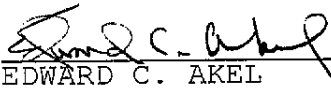

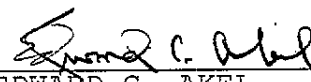
The Company shall be effective October 1, 2002 and shall have perpetual duration.
