**ARTICLES OF ORGANIZATION
OF
ALLIED COMMODITIES GROUP, L.L.C.**

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

1. **Name.** The name of this limited liability company is Allied Commodities Group LLC ("Company").

2. **Duration.** The Company shall exist from the date of filing these Articles with the Department of State in perpetuity or until the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by the unanimous consent of all of the remaining members.

3. **Mailing Address and Street Address.** The Company's mailing address and street address is 7840 Boca Ciega Drive, St. Pete Beach, Florida 33706.

4. **Registered Agent and Office.** The name of the initial registered agent of the Company is Michael A. Lingo. The street address of the initial registered agent of the Company is 7840 Boca Ciega Drive, St. Pete Beach, Florida 33706.

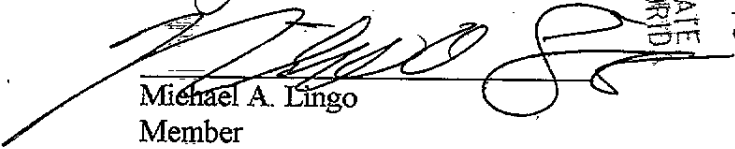
