ARTICLES OF ORGANIZATION
OF
BUSY B CONCIERGE, L.L.C.
(a Florida Limited Liability Company)

The undersigned certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of limited liability companies for profit.

ARTICLE I
(Name and Principal Place of Business)

The name of the limited liability company is Busy B Concierge, L.L.C., and the mailing address and street address of its principal office is 749 Helicon Terrace, Vero Beach, Florida 32958.

ARTICLE II
(Duration)

ARTICLE V
(Right to Continue Business)

On the death, withdrawal, resignation, expulsion, bankruptcy or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in the limited liability company, the remaining members shall have the right to continue the business on the consent of a majority (or all) of the remaining members within ninety (90) days of the terminating or dissolving event.

ARTICLE VI
(Management)
