These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

**ARTICLE I**

Name: The name of this limited liability company is Café Cardozo, LLC (the "Company").

**ARTICLE II**
