The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, hereby make, acknowledge, and file the following Article of Organization.

ARTICLE I – Name and Principal Place of Business

The name of the limited liability company shall be **Doc's Auto, L.L.C.** (hereinafter the "Company"). The principal place of business of the Company shall be 3655 West Orange Avenue, Tallahassee Florida. The mailing address shall be 3655 West Orange Avenue, Tallahassee, Florida 32310.

The name and street address of the registered agent of the Company in the State of Florida is Stephen Love, 1519 Bowman Drive, Tallahassee Florida, 32308.

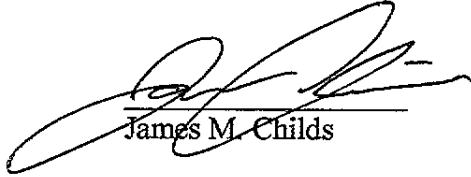
ARTICLE V – Management

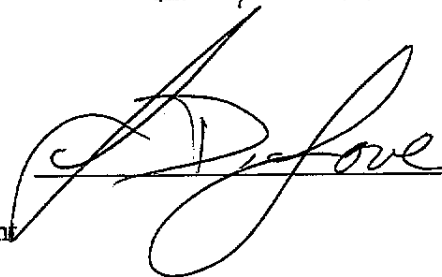
