ARTICLES OF ORGANIZATION
OF
THE TENNYSON, LLC

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (the “Act”), for the purpose of forming a Limited Liability Company under the laws of the State of Florida does set forth the following:

1. **NAME.**

The name of the Limited Liability Company is THE TENNYSON, LLC (hereinafter referred to as the “Company”).

2. **PERIOD OF DURATION.**

The period of duration of the Company shall be from the date of filing of its Articles of Organization until the first to occur of the following:

- (i) Dissolution of the Company pursuant to the provisions of the Florida Limited Liability Company Act; or
- (ii) By the written agreement of a majority in capital interest of the Members.

3. **ADDRESS OF PLACE OF BUSINESS.**

The initial primary business and mailing address for the Company is 226 South Palafox Street, Suite 101A, Pensacola, Florida 32501. Such address may be changed from time to time as provided in the Operating Agreement.

4. **REGISTERED AGENT.**

The initial registered agent in Florida for the Company is Kenneth E. Granger, III, and the initial registered office is located at 226 South Palafox Street, Suite 101A, Pensacola, Florida 32501.

5. **CAPITAL CONTRIBUTIONS.**

Contributions to the capital of the Company shall be made by the Members, from time to time, in the manner prescribed by a written Operating Agreement to be made and entered into by the Members, and which may be amended from time to time in accordance with its terms.

6. **MEMBERS.**

The Company shall have at least one (1) Member, and may admit additional members upon the prior unanimous written agreement of the then existing Members, or as otherwise provided in the Operating Agreement.

7. **MANAGEMENT.**

Management of the Company shall be by a Manager (or Managers), who shall be elected in the manner provided for in the Operating Agreement.

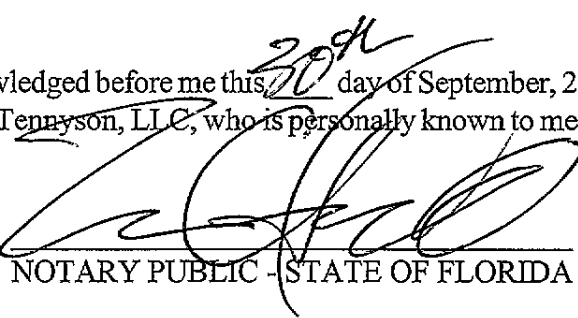

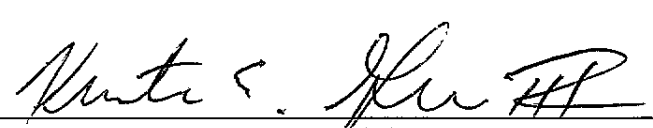
