Management**

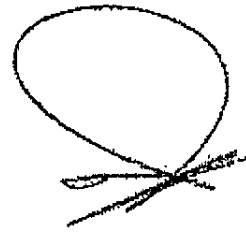

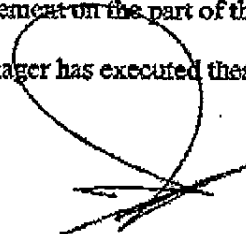
