# ARTICLES OF ORGANIZATION

OF

## MICROANALYTICA, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization—

## ARTICLE 1 - NAME

The name of the limited liability company shall be MICROANALYTICAPLLE ("Company").

## **ARTICLE 2 - ADDRESS**
