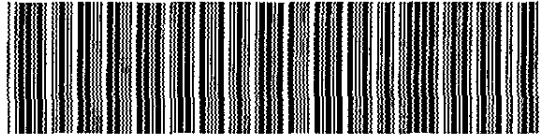

The Company will be managed by at least one (1) manager and is, therefore, a manager-managed company. The initial managers shall be:


