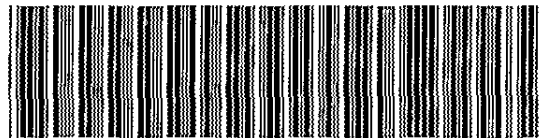

First: The date of filing of the articles of organization of 524 HENDRICKS LLC was October 4, 2002,


Second: The following amendment to the articles of organization of 524 HENDRICKS LLC should be executed as follows:
