The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE 1-NAME

The name of the limited liability company shall be COLLEGE ENTERTAINMENT NETWORK, LLC, ("Company").

#### **ARTICLE 2 – ADDRESS**
