**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION  
OF  
CHISPA RESTAURANT, LLC  
(a Florida limited liability company)**

**FIRST.** The date of filing of the Articles of Organization was October 7, 2002.

**SECOND.** The following amendment to the Articles of Organization was adopted by the limited liability company:
