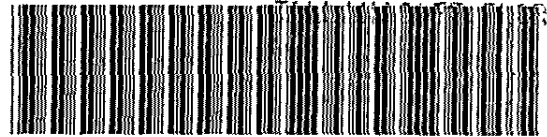

**ARTICLES OF DISSOLUTION

Pursuant to Sections 608.441, 445, 446 of the Florida Statutes, the remaining member adopts these Articles of Dissolution.

FIRST: The name of the business entity is **J & B Mechanical, LLC.**

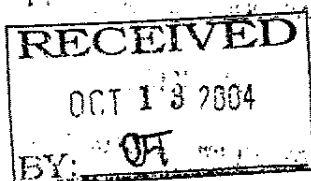
