THIRD: The name and the Florida street address of the registered agent are Corporation Service Company, 1201 Hays Street, Tallahassee, Florida 32301.



A Member, acting in his or her capacity as a manager of the Limited Liability Company (a "Manager"), shall not be personally liable for damages for any breach of duty in such capacity as a Manager, except for damages resulting from actions or omissions by such Manager as to which there shall have been a judgment or other final adjudication which established that: (a) such acts or omissions were in bad faith, or involved intentional misconduct or a knowing violation of law; (b) such Manager personally gained an improper personal benefit or other advantage to which he or she was not legally entitled; or (c) with respect to a distribution which is the subject of Chapter 608 Section 426 of the Florida Limited Liability Act (the "Act"), such Manager's acts were not performed in accordance with Chapter 608 Section 4225 of the Act.
