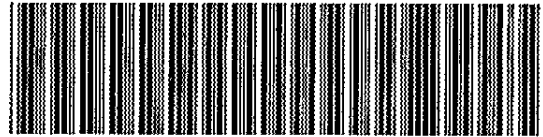

Article IV – Management**


To delete and remove the name of Yves Barroukh as a managing member of the LLC.
