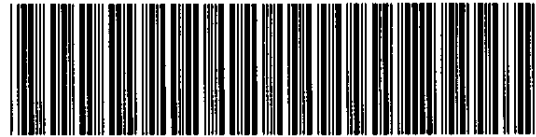

**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF
CARIBBEE ASSOCIATES, LLC**

The undersigned, having filed on October 8, 2002, the original articles of organization of CARIBBEE ASSOCIATES, LLC, a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Amended and Restated Articles of Organization.

**ARTICLE I
