ARTICLE I.

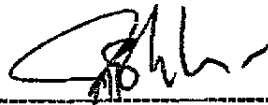
The name of this limited liability company is: Blake and Associates, LLC.

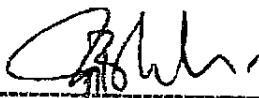
