AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF RIVER BAIT AND TACKLE, LLC

(a Florida limited liability company)

The undersigned, as the sole member of RIVER BAIT AND TACKLE, LLC, a Florida limited liability company (the "Company"), hereby amends and restates the Articles of Organization of the Company and certifies that:

- 1. The name of the Company is RIVER BAIT AND TACKLE, LLC.
- 2. The Articles of Organization of the Company were originally filed with the Secretary of State of the State of Florida on October 9, 2002.
- 3. These Amended and Restated Articles of Organization restate and amend the provisions of the Company's Articles of Organization, in their entirety, to change the address and registered agent of the Company and to set forth only the minimum information required under Florida law as follows:
