

ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a professional limited liability company under the Professional Service Corporation and Limited Liability Company Act, Florida Statutes, Chapter 621, hereby makes, acknowledges, and files the following Articles of Organization.

<u>ARTICLE I - NAME</u>
