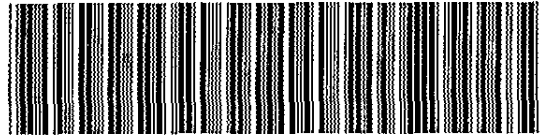

**ARTICLES OF DISSOLUTION**

- FIRST:** The name and address of this corporation is **GG&A REAL ESTATE, LLC**, 4301 Royal Palm Avenue, Miami Beach, Florida 33140.
- SECOND:** The date of the adoption of these Articles of Dissolution is 2 April 2003.
- THIRD:** The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 608.4421. The remaining property and assets have been distributed among its members in accordance with their respective rights and interests.
