ARTICLES OF ORGANIZATION

OF

THE MEMORY CLINIC, L.L.C.

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be THE MEMORY CLINIE L ("Company"). The principal place and mailing address of business of the Company in Florida shall 1101 S. Tamiami Trail, Unit 208, Venice, Florida 34285.

ARTICLE II

DURATION

members.

MANAGEMENT

The Company shall be managed by a manager in accordance with regulations adopted by the members for the management of the business and affairs of the Company. The regulations may contain any provision for the regulation and management of the affairs of the Company not inconsistent with law of these Articles or Organization.
