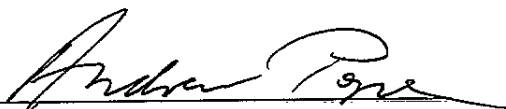
**ARTICLE SEVEN
AMENDMENT OF ARTICLES**

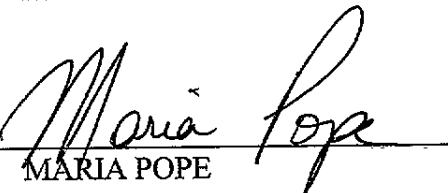
