ADMISSION OF ADDITIONAL MEMBERS

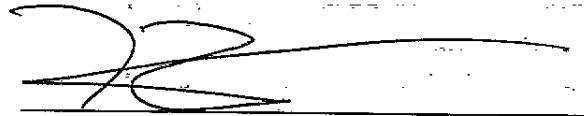
Upon approval by 51% of the Members, the company is authorized to issue additional Units in the company and to admit Additional Members to the Company.

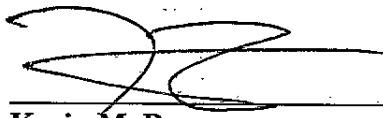
