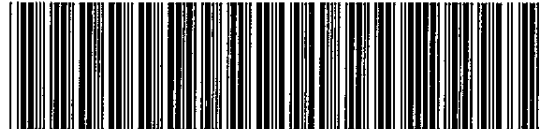

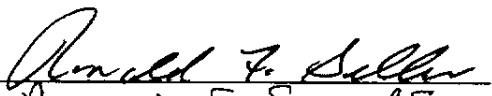
"ARTICLE I - NAME
