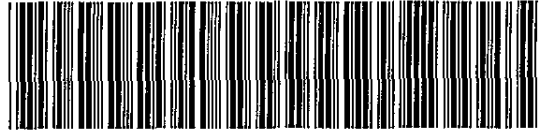



**"ARTICLE I - NAME**


The name of the Limited Liability Company is
