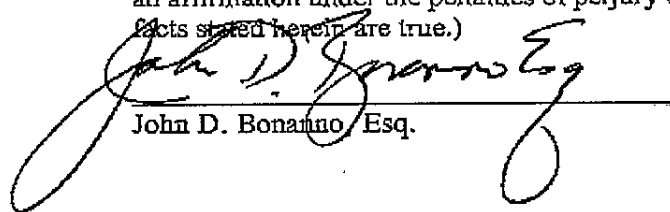
**ARTICLE VII:

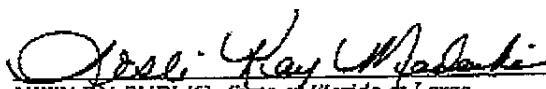

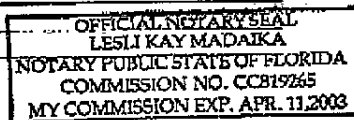

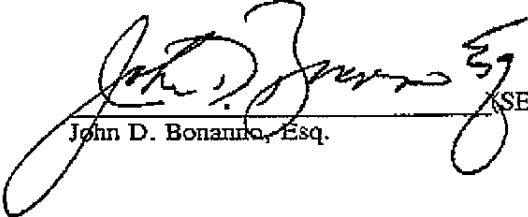
