## ARTICLES OF ORGANIZATION

##### Registered Office and Agent

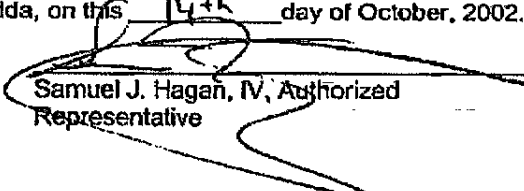
