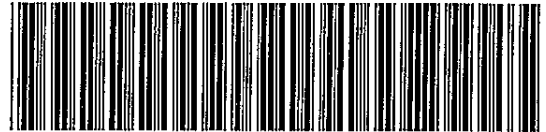



**FIRST:** The date of filing of the articles of organization was October 16, 2002, effective date October 1, 2002


**ARTICLE VIII - MANAGEMENT**

All other Articles contained in the Articles of Organization remain unchanged.



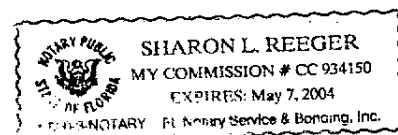


