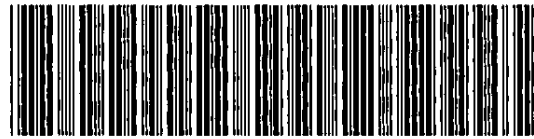

THESE ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION of MORADA CLOUD HOLDINGS, LLC, A FLORIDA LIMITED LIABILITY COMPANY (the "Company") are dated as of October 10, 2012. The Articles of Organization of the Company were filed on 10/15/2002 and assigned document number L02000027321, and were amended on 03/03/2003.

After a vote by all Members of the Company, desiring to amend the Articles of Organization of the Company originally filed on 10/15/2002 and amended on 03/03/2003, the Company hereby declares and confirms that all Members agree and have unanimously voted that the Articles of Organization of the Company, are hereby amended as follows:

1. The Articles of Amendment filed by the Company on 03/03/2003 inadvertently list the company as Member managed, whereas the Operating Agreement of the Company states that the Company is Manager managed by Morada Ventures, Inc., who is in fact a Member of the Company.
2. Accordingly, the following Entity is hereby declared to be the sole Manager of the Company as set forth in the Operating Agreement of the Company, and Cloud Nine Holdings, Inc. is declared not to be a Manager of the Company:

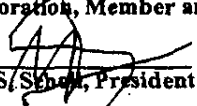
