#### ARTICLES OF ORGANIZATION

#### FBA Investments, LLC

#### A LIMITED LIABILITY COMPANY

(Pursuant to s. 607.407, Florida Statutes)

- 1. Name. The name of the limited liability company is FBA Investments, LLC.
