THIRD AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF BALDWIN PARK VILLAGE III, L.L.C.

The Further Amended and Restated Articles of Organization of Baldwin Park Village III, L.L.C., as filed on July 30, 2004, as assigned Florida document number L02000027572 and as amended by Amendment to the Further Amended and Restated Articles of Organization filed August 4, 2004 and by Second Amendment to the Further Amended and Restated Articles of Organization filed August 13, 2004, are hereby further completely amended and restated in their entirety as follows:

ARTICLE I NAME

The name of this limited liability company (this "Company") is BALDWIN PARK VILLAGE RESIDENTIAL III, L.L.C., and its mailing address is 1999 Avenue of the Stars, Suite 1260, Los Angeles, CA 90067 and the principal place of business of the Company shall be located at 1999 Avenue of the Stars, Suite 1260, Los Angeles, CA 90067.

ARTICLE II COMMENCEMENT OF EXISTENCE

This Company shall commence existence on the date of the signing the original articles of organization of October 16, 2002, and shall have perpetual existence unless sooner dissolved according to law.
