**ARTICLES OF ORGANIZATION OF
REVENGE LT, LLC**

The undersigned, for the purpose of forming a limited liability company under Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of this limited liability company shall be REVENGE LT, LLC (hereinafter referred to as the "Company").


ARTICLE IV - REGISTERED AGENT

The Company shall be manager-managed by one or more managers.


