**ARTICLE I**

The name of the Company is: **ZINGARO, L.L.C.**

**ARTICLE II**



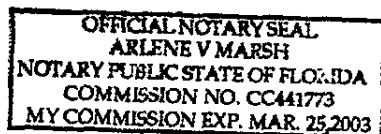
