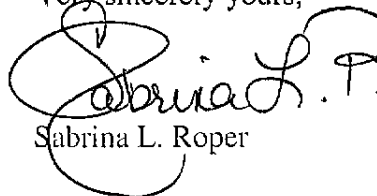

ARTICLES OF ORGANIZATION FOR

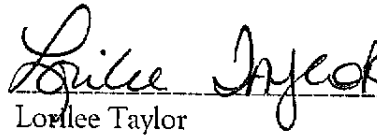
