

# ARTICLES OF ORGANIZATION OF P & S CONSULTING, LLC

The undersigned, acting as organizer of P & S Consulting, LLC, under the Florida Limited Liability Company Act ("the Act"), adopts the following Articles of Organization for said limited liability company:

### ARTICLE I NAME
