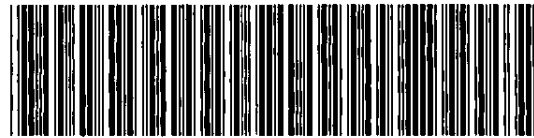

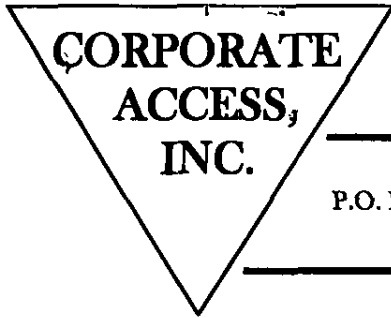

**ARTICLES OF AMENDMENT  
TO ARTICLES OF ORGANIZATION  
OF  
EPSILON, L.L.C.**

The undersigned being one of the members of EPSILON, L.L.C., a Florida Professional limited liability company (the "Company"), in accordance with the provisions of Chapter 608, Florida Statutes, hereby amends its Articles of Organization as set forth below:

1. The name of the Company is EPSILON, L.L.C.
2. The Articles of Organization for the Company were filed with the Florida Department of State on October 21, 2002.
3. Article IV of the Company's Articles of Organization is hereby deleted in its entirety and the following is substituted therefor:


**"ARTICLE IV.**

4. These Articles of Amendment shall be effective upon filing with the Florida Department of State.

6. Except as expressly provided herein, all of the terms and provisions of the Articles of Organization shall remain in full force and effect and are hereby ratified and confirmed.
