Management of the Company is vested in the members in accordance with these Articles or such operating agreement agreed to by the members of the Company, or the Florida Limited Liability Company Act.

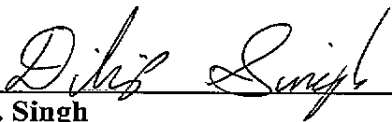
**ARTICLE V. – EFFECTIVE DATE**
