

The undersigned member hereby forms a Limited Liability Company under Chapter 608 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the Limited Liability Company (“Company”) is: ASPEN VISTA, LLC.

This Company shall commence its existence with \$100.00 cash as its contributed capital. There are no additional contributions to be made by the members except as determined by unanimous consent of the members.


ARTICLE VI. MANAGEMENT

ARTICLE VII. INITIAL REGISTERED OFFICE AND REGISTERED AGENT


1. The name of the initial registered agent of the Company is Ben M. Bergaoui.

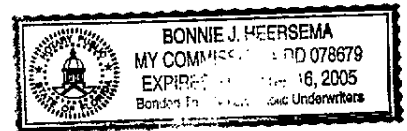
