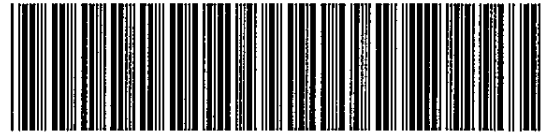

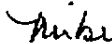

SECOND: The following amendment to the Articles of Organization were adopted by the limited liability company:

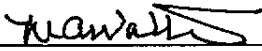
