ARTICLE I - Name



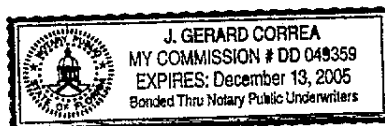
