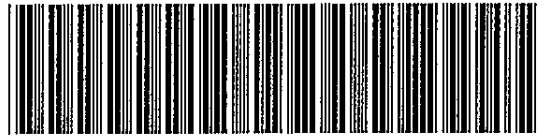



The name of this limited liability company (the "Company") is **505 NORTH MYRTLE, LLC**.


Except as amended hereby, the Articles of Organization shall remain in full force and effect.
